Objective and investment policy

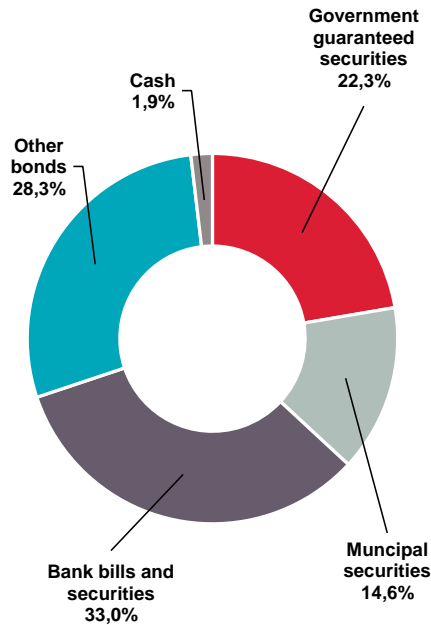
IS Bond Fund is an investment fund (non-UCITS) that invests in government-guaranteed bonds, municipal securities, financial institution bills, notes and deposits and other corporate and institution bonds. The average maturity of the Fund's portfolio can be 0-14 years. It is the Fund Managers responsibility to decide on whether to invest in long or short term bonds as well as indexed or non-indexed bonds.

The Fund is an investment fund and its investment authorizations are based on Act no. 128/2011. The Fund may invest up to 20% in other bonds, including corporate bonds.

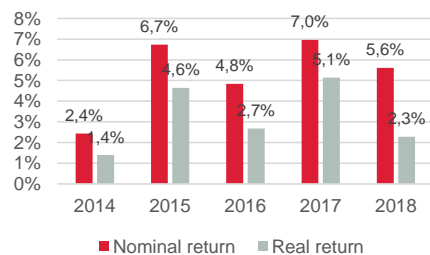

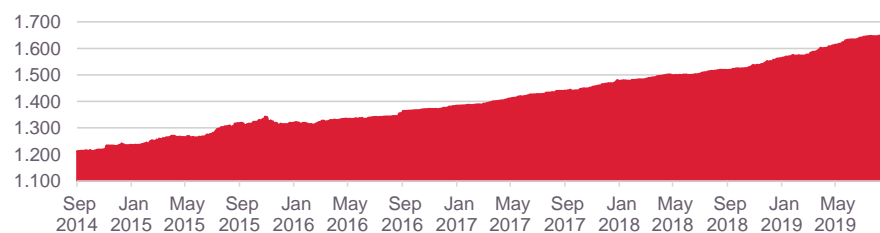
