## Objective and investment policy

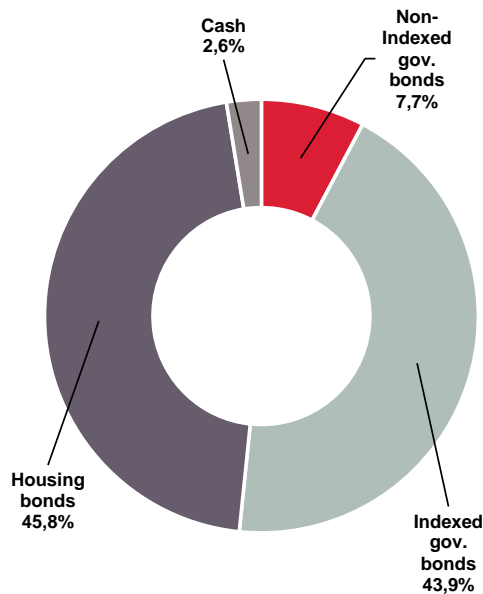
IS Long-Term Government Bond Fund is a UCITS mutual fund that invests in bonds issued by The Housing Financing Fund (HFF). The fund may also invest up to 30% of its assets in other bonds issued by the National Treasury, such as Treasury bills and Treasury bonds. The fund may own as much as 10% in liquid assets to meet redemptions or temporarily due to market circumstances.

The estimated duration of the fund is 6 - 12 years.

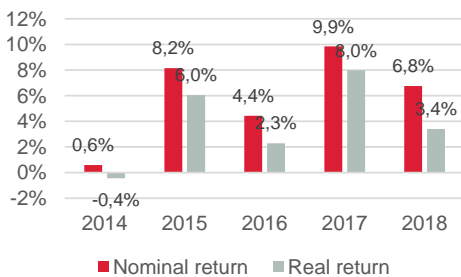

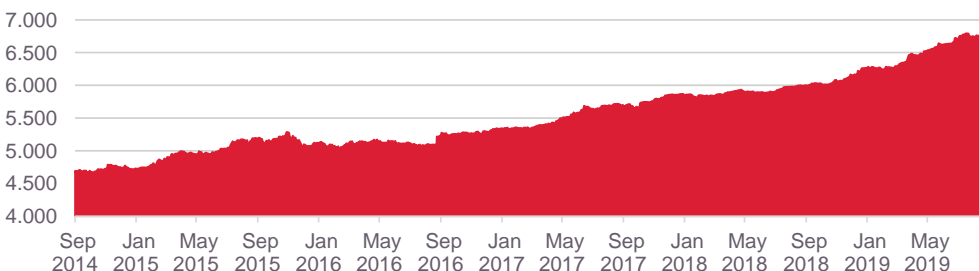
