## Objective and investment policy

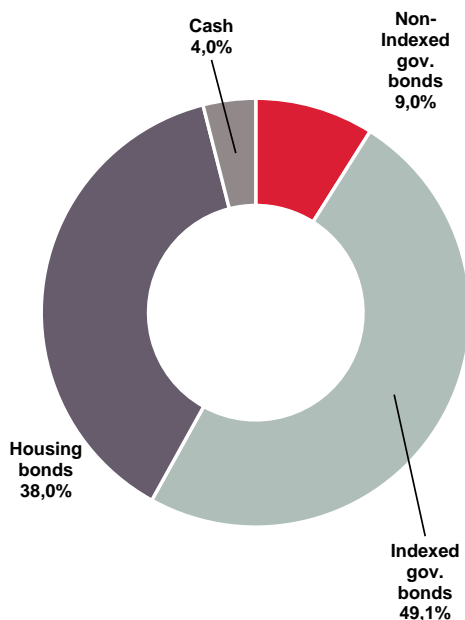
IS Long-Term Government Bond Fund is a UCITS mutual fund that invests in bonds issued by The Housing Financing Fund (HFF). The fund may also invest up to 30% of its assets in other bonds issued by the National Treasury, such as Treasury bills and Treasury bonds. The fund may own liquid assets to meet redemptions or temporarily due to market circumstances.

The estimated duration of the fund is 6 - 12 years.

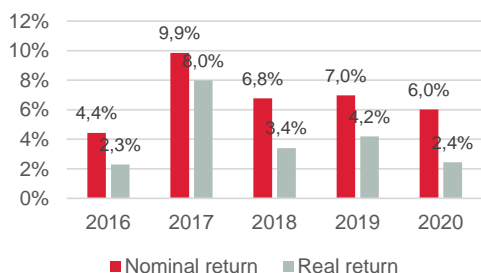

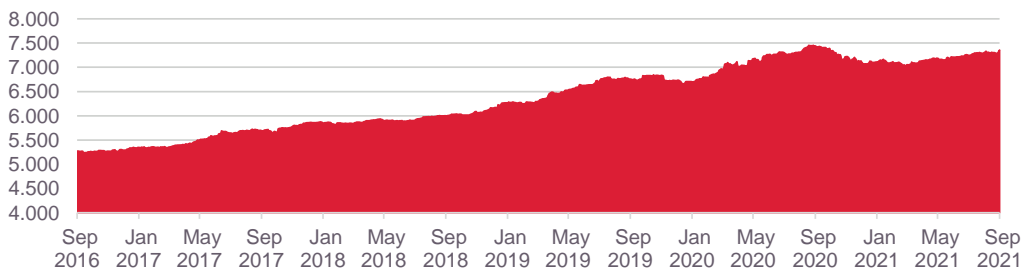
